Conditions of Storage

1) **Definitions** – In this agreement :

- a. “**NAS**” means the Napan Agricultural Show;
- b. “**Owner**” means the undersigned person whom ownership of the **property** is vested. In the event that the undersigned is not the **owner** of the **property**, then the undersigned hereby covenants with the **NAS** that he/she is the duly authorized agent of the **Owner** with full power on behalf of the **Owner** to enter into this agreement;
- c. “**Property**” means the personal **property** of the **owner** herein listed.
- d. Standard fee of \$250.00 per vehicle (camper, boat, car, motorhome, etc.)
- e. Vehicle ((camper, boat, car, motorhome, etc.) must not contain any stored fuel/propane.

- 5) I, the undersigned, being the **Owner**, in consideration of the storage of the above named **property** by the **NAS**, do hereby remise, release and forever discharge the **NAS**, its successors and assigns of and from all manner of actions, causes of actions, suits, debts, dues, accounts, bonds, covenants, claims and demands whatsoever which against the said **NAS** I ever had, now have or which I may hereafter acquire or which my heir, executors, administrators or assigns of any of them, hereinafter can, shall or may have for or by reason of any cause, matter or thing whatsoever.

And, further, I, the **Owner** do hereby covenant and agree with the **NAS** that I will at all times hereinafter indemnify and save harmless the said **NAS** from all claims and demands, suits or actions or claims for contributions or indemnity whether under the contributory Negligence Act or otherwise, which may be made or brought against the **NAS**, by the **Owner**, his heirs, executors, administrators or assigns, or on his behalf or in any arising out the loss, theft, destruction or damage to the property, including the cost of a solicitor and client basis of defending any suits, actions or claims aforesaid.
